

Two individuals with unique backgrounds and struggles were able to find solace and support amidst the challenges of homelessness. Their journey in finding not just a place to stay, but a place to call home, is a testament to the profound impact that your support of Beacon has made.

Tina's path to Friend's Place was marked by a near-fatal car accident that left her hospitalized with a fractured spine, ribs and broken ankle in two places. The lack of support from her ex-





## **Finding the Light**

Six staff members and I recently traveled to Terre Haute for an all-day conference on housing and homelessness. While there were definite nuggets of knowledge I brought home from the workshops and speeches, the most memorable moment of the conference was the former client I ran into who was now working on the conference staff. Dressed in a crisp black shirt and pants, he and I recognized each other immediately with smiles. He told me he had been in recovery for several years and was doing very well. He had a home and was working full-time. I told him I was so happy for him and proud of him.

JR's journey to Friend's Place was marked by the twists and turns of life's unpredictable path. After his time serving in the Air Force, JR settled in Muncie, where he lived with his daughter and mother-in-law. However, when circumstances forced them to relocate to Bloomington, tensions with his daughter's boyfriend reached a breaking point, leading JR to seek solace at Friend's Place. With the assistance of another agency, JR was able to secure housing in Indianapolis. However, the apartment's lack of accessibility led to unforeseen mobility challenges for JR. Recognizing the need for a more suitable solution, JR made the call to reach out to Friend's Place's program director, Lindsey, expressing his desire to return and devise a better plan. "[Without Friend's Place] I doubt I would be sitting right here right now."

JR reflected. "The people there, to do that job, you've got to care."

Tina and JR's paths had crossed before, but it was at Friend's Place that their connection blossomed. Through shared experiences and mutual support, they found comfort and companionship in each other. With JR's appreciation for Friend's Place staff and Tina's gratitude for the sense of family they found with both staff and guests, Friend's Place became more than just a shelter. It became a place where Tina and JR could connect, receive support, and begin rebuilding their lives. In addition to the refuge the physical space was able to provide, the array of supports offered by Friend's Place staff including assistance with locating housing, applications, and deposits as well as offering emotional support, allowed Tina and JR to transition from homelessness to stability in a home of their own.

Tina and JR's journey is evidence that a safe space to seek refuge combined with the support of a caring community can light the way forward. In their time at Friend's Place, Tina and JR found not only a place to stay, but also a chosen family and a place to call home.

But, it's also easy to miss how many people have used us as a runway to a better life.

Some volunteers and I visited Goodwill Commercial Services recently to explore some potential employment partnerships between our two agencies. While walking through their manufacturing facility, I ran into two employees who had been guests of our facility. Just like in Terre Haute, we smiled and expressed excitement over their accomplishments.

Another staff member shared how several former clients had recently called to tell us how well they were doing: one person relocated to TN and has a home and a job, another has a home in Indy and is saving for a car, and a third had moved into sober living and was thriving.

These are the stories that sustain us, that carry us through, that remind us that this awful moment is not every moment, this horrible instance is not forever.

Beacon is a healing place for the traumatized of our world. Thank you for creating such a place with your gracious support as volunteers, donors, and advocates.
