DONOR ACKNOWLEDGMENT

Pursuant to IC6-3.1-9-3, credits provided by the Neighborhood Assistance Program (NAP) shall only be applied against any IN state tax liability owed by the taxpayer after the application of any credits, which under IC6-3.1-1-2 must be applied before the credit provided under NAP. In addition, the tax credit that a taxpayer receives under NAP may not exceed \$25,000 for any taxable year of the taxpayer.

INFORMATION ON NEIGHBORHOOD ASSISTANCE PROGRAM (NAP) TAX CREDITS

If you're unfamiliar with NAP, the program allows Indiana donors to receive a credit (not a deduction, but a credit) against their state income tax liability in the amount of 50% of their contribution.

Where a deduction reduces your taxable income, a credit directly reduces the amount you owe in taxes, so **credits bring you much greater savings than deductions.**

For example, a \$500 donation to Beacon, Inc. will give you a \$250 reduction on the taxes you owe on your 2026 Indiana State Tax return. (As usual, the full \$500 donation may also be eligible as a deduction on your federal income tax return.)

To receive a credit, *please note the following essential instructions.*

- **All donations must be accompanied by the enclosed Donor Contribution Form (see reverse). The form must be completed in full.** Please read the directions carefully as improperly filled out forms could risk your credits.
- Credits are sadly limited and will be distributed on a first-come, first-serve basis.
- The minimum donation eligible for NAP credits is \$100.
- To offer credits to as many supporters as possible, the maximum donation eligible for NAP credits from Beacon is \$1000.
- The name on the check must match the name of the contributor, the social security number given, AND the name on your taxes. This is important as an error could create difficulties for you when trying to claim your credits.
